Dear Members,

It appears that the renewal of your membership with PDEXCIL for this financial year (2022-23) escaped your attention and stand 'not renewed' status as per our record.

Please note that, in terms of clause 13(a) (i) of the Articles of Association of the PDEXCIL, the membership of the council is on yearly basis (Financial Year April-March) and is required to be renewed from 1st April 2022. Moreover on failure to pay subscription or dues, except penalty on the expiry of a period of three months (i.e 30th June 2022) from the date on which the subscription or dues fell due which shall be 1st April of every year, and no member whose subscription is in arrears at the time of such voting shall be entitled to vote. However if the member renew their membership after expiry of the above said three months period (i.e.30th June 2022) they may continue as member without any voting power for the said financial year (i.e FY 2022-23).

Hence it is requested to renew your membership by sending RTGS/Demand Draft/Cheque of Rs.2360/- favoring "Powerloom Development and Export Promotion Council" payable at Mumbai on or before 30th June 2022 to avail benefit of voting rights during the election of COA/Vice-Chairman/AGM/EGM. Kindly mention your Membership No, Company name, Mob./Tel. No and email along with your GST No on the reverse of the Demand Draft/Pay Order/Email.
